

Through the support of a global network of more than 145,000 alumni, the Alumni Association enhanced the student experience and encouraged future alumni involvement and a lifelong commitment to UAlbany.



World Within Reach Speaker Series: Provided \$15,000



in underwriting support for the Student Association series and promoted this high profile event to the alumni community. This series included a guest appearance by General Colin L. Powell and a debate by Karl Rove and Howard Dean.

- Purple & Gold Ambassadors: Coordinated, managed and provided valuable training in networking and communications for our student ambassadors.
 Ambassadors represented the University and rendered more than 100 hours of service.
- Expansion of Mentor Program: Recruited 175 new mentors as part of our online mentoring network.

Provide Student Scholarship

The Alumni Association contributed money to support students' needs and enhance their academic experience.

- Overall Support: Donated \$100,000 toward student scholarships.
- School Spirit Scholarship: Created a scholarship to be awarded to three current UAlbany sophomores, juniors or seniors to help promote and recognize student involvement, school spirit and pride.
- Online Scholarship Access: Moved the Alumni Association scholarship application process online to create easier access and greater exposure for students and alumni.

Support Institutional & Academic Priorities

The Alumni Association provided funding to support student and alumni partnership programs with priority placed on guest lectures, mentoring and donor stewardship.



• Examples of programs we have supported: School of Social Welfare Luncheon, Citizen Laureate Dinner, School of Public Health, Donor Events, Conferences, Reunions, Speakers, Fundraising Drives, Student Groups and the Arts.

Help Attract the Best Students

Through collaboration with Enrollment Management the Alumni Association played a critical role in recruiting strategies.

- Accepted Student Receptions: Coordinated student receptions in Westchester, Syracuse and Long Island with more than 120 students attending.
- Calling Program: Directed Spring Alumni Admissions Calling Program where more than 90 alumni reached out to over 400 accepted students. Developed new Web page for Admissions Ambassadors



Program, coordinated Legacy Program and hosted alumni panels at Spring and Fall Open Houses.

Promote University Brand & School Affinity

The Alumni Association expanded upon and increased services and benefits to alumni and further engaged them in the life of the University.

- Affinity Groups: Established Five Quad, Jewish Alumni Network and Theater Department groups.
- Graduates of the Last Decade (GOLD) Programs: Continued support of our "newest" alums through social events, reunion activities and creation of a GOLD giving program.
- Alumni Volunteer Council: Prepared plan of action for council to recruit, retain and recognize volunteers. Implemented new online tools to promote and encourage new alumni volunteers. Volunteers in 25 service areas completed 1,000 service hours.

Enhance Philanthropy through Expanded Alumni Engagement

The Alumni Association established additional programming that enabled the University to develop closer ties with its students and alumni.

- Varsity Club: Planned and hosted 22 pregame events, Dinner with the Coaches and a successful lunch/dinner with the coach's series, engaging more than 120 alumni throughout the season.
- Events: Armchair discussion with President George Philip '69, '73, collaboration with Office of University Events on alumni donor reception.
- Donor Thank You Calling Program: Established in Fall 2009 a program in which alumni reached out to first time donors. We have successfully contacted more than 250 alums in the first quarter.

Engage Alumni from Diverse Backgrounds

The Alumni Association produced and coordinated programs and events including Homecoming, Big Purple Growl, Excellence Awards Gala, alumni ambassadors, reunions, regional events, constituent-based engagement and communications.
