<sup>e</sup>Ever used a needle to inject any illegal drug.

<sup>f</sup>Ever used heroin (also called smack, junk, or China White).

<sup>g</sup>Ever used methamphetamine (also called speed, crystal, crank, or ice).

<sup>h</sup>Ever used ecstasy (also called MDMA).

<sup>i</sup>Ever sniffed glue or breathed the contents of aerosol spray cans or inhaled any paints or sprays to become intoxicated.

<sup>j</sup>Ever used hallucinogenic drugs (also called LSD, acid, PCP, angel dust, mescaline, or mushrooms).

<sup>k</sup>Ever had one or more drinks of alcohol.

<sup>l</sup>At least one drink of alcohol on 1 or more of the 30 days preceding the survey.

<sup>m</sup>Drank five or more drinks of alcohol in a row (within a couple hours) on 1 or more of the 30 days preceding the survey.

<sup>n</sup>Ever tried cigarette smoking, even one or two puffs.

<sup>o</sup>On 1 or more of the 30 days preceding the survey.

<sup>p</sup>Smoked cigarettes on 20 or more of the 30 days preceding the survey.

<sup>q</sup>More than a few sips.
