^bIncludes compulsory and confirmed deportations pursuant to an order by an immigration judge. Also includes exclusions of arriving aliens, which involve denial of entry into the United States based on a finding of inadmissibility by an immigration judge or by authority of immigration officials through an expedited removal process.

^cBeginning in 2008, excludes criminals removed by Customs and Border Protection.

^dA form of relief from formal removal under which an alien is permitted to depart voluntarily. Most of the voluntary departures are Mexican nationals who have been apprehended by the U.S. Border Patrol and are returned to Mexico.
