Note: These data are from the National Survey of Substance Abuse Treatment Services (N-SSATS), which is conducted by the Substance Abuse and Mental Health Services Administration. The survey includes both public and private treatment facilities in the 50 States, the District of Columbia, and U.S. territories and protectorates. The reference date for the 1998 and 2000 N-SSATS was October 1; for the 2002 N-SSATS it was March 29; for the 2003 through 2006 N-SSATS it was March 31; and for 2007 it was March 30. The response rate for the 2007 survey was 94.5%. The reference date for both the 2008 and 2009 surveys was March 31; the response rates were 94.1% and 93.4%, respectively.
