Note: These data were collected by the U.S. Department of Justice, Bureau of Justice Statistics through the National Prisoner Statistics (NPS) program. The NPS program provides year-end data for the prisoner populations of the 50 States, the District of Columbia, and the Federal Bureau of Prisons. These data represent the custody population, which includes only those prisoners housed in a jurisdiction's facilities. Indiana did not report the number of HIV/AIDS cases for 1995-2004. Some data have been revised by the Source and may differ from previous editions of SOURCEBOOK.

<sup>b</sup>5,483 confirmed AIDS cases are based on reported data. The estimated total number of confirmed AIDS cases is 6,027; this includes estimates for the following States not reporting these data for 2004: Arizona, Georgia, Idaho, Indiana, Louisiana, Michigan, Oklahoma, and Virginia. Estimates were based on the most recent data available.

<sup>c</sup>At yearend 2001, responsibility for housing District of Columbia sentenced prisoners was transferred to the Federal Bureau of Prisons.

<sup>a</sup>Percentages are based on custody counts, except for New Mexico. From 2000 to 2004, New Mexico's percentages are based on its yearend jurisdiction count.
