Conditional Admission



Is your TOEFL or IELTS score too low for Albany Law School?

Albany Law School offers Conditional Admission to international applicants who meet the academic requirements of the university but whose TOEFL or IELTS score does not meet the minimum language proficiency requirement.

Through conditional admission, students must successfully complete the highest level in University at Albany's Intensive English Language Program (IELP) with minimum grades of B- in all classes. Students who wish to receive Conditional Admission to Albany Law School must apply to both Albany Law and IELP.



Apply for Conditional Admission to Albany Law School:

- Visit <http://www.albanylaw.edu/admissions/apply>.
- Review the application requirements and deadlines for the LL.M. program.
- Complete the online application. Paper applications are NOT accepted.
- Register with the LSAC Credential Assembly Service (CAS) to submit your transcripts, LSAT score, and letters of recommendation.
- Submit any additional materials required by Albany Law School.

Apply to the Intensive English Language Program:

If you are not currently a student in the IELP, please visit www.albany.edu/ielp and click on "Apply."



The IELP will send you an I-20 to use with your conditional admission letter from Albany Law Admissions. Please take the I-20 and your conditional admission letter when you go to the embassy or consulate for your visa interview.

The IELP offers 8-week sessions. There are 7 language levels. You will be placed in the appropriate language level after taking a placement test. However, if you submit a TOEFL and IELTS test score to the IELP above 61 iBT or a 5.5 IELTS score prior to your arrival, you will be automatically placed in an Advanced Level of the IELP. The Advanced 1 and Advanced 2 Levels each take 8 weeks to complete.

Upon completing the IELP, your I-20 will be transferred to Albany Law School.

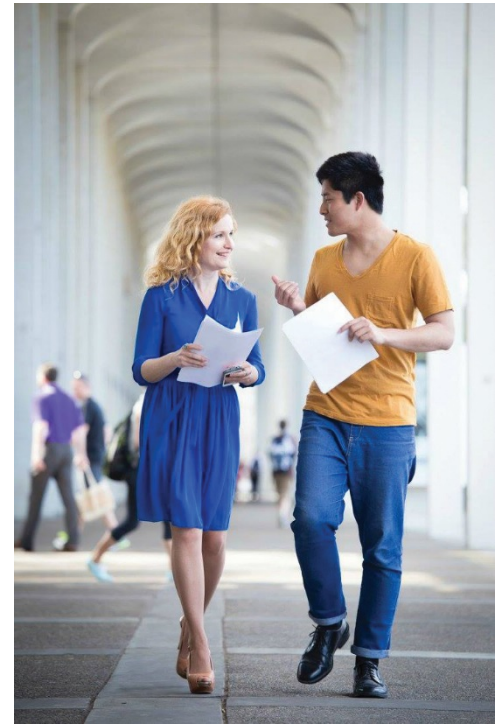

How to Apply to the IELP

3 Easy Steps!

- Step 1:** Fill out an application form online at www.albany.edu/ielp/apply_now.php. Your name and date of birth must be the same as on your passport.
- Step 2:** Obtain a financial guarantee letter from your bank and email it to IELP@albany.edu. You must show proof of a minimum of USD \$6,500 (or the equivalent in your local currency) on deposit available for your school and living expenses in the requested session.
- Step 3:** Copy the picture page of your passport and email it to IELP@albany.edu.
