



Request for Form DS-2019 – Certificate of Eligibility for Exchange Visitor (J-1) Status

The University at Albany and The SUNY Research Foundation sponsor exchange visitors in the program categories listed below. The U.S. Department of State requires that sponsors screen and select their participants according to the eligibility criteria for each category. Please read the criteria below and select the appropriate category for the exchange visitor named in this request.

Professors and Research Scholars

Visitors may not be present in the U.S. in any J status for any part of the 12-month period preceding the start date of their program unless they are transferring to the program, were in the short-term scholar category, or were not present in the U.S. for more than six months; participants are not eligible to return to the U.S. in the professor/research scholar category for a period of 24-months immediately following completion of any program in this category. The minimum program duration for this category is 3 weeks; the maximum program duration is 5 years. Candidates for tenure track positions are not eligible.

Short-Term Scholars

Visitors are professors, research scholars, or persons with similar education or accomplishments sponsored by the University to lecture, observe, consult, train, or demonstrate special skills on a short-term visit, not to exceed 6 months (extensions not permitted). The minimum program duration of 3 weeks is waived for participants in this category.

Students Associate’s Degree Bachelor’s Degree Doctoral Degree Master’s Degree Non-Degree

Students in degree programs are authorized to participate in this category for the duration of their program of study; the maximum program duration for students in non-degree programs is 24 months. Students in either degree or non-degree programs must pursue a full-time course of study and maintain satisfactory advancement toward the completion of their academic program. Before issuing form DS-2019 the student must have the academic credentials required for the program, and must be admitted to the University at Albany.

Student Intern – MUST ATTACH FORM DS-7002

The department is required to submit the additional form DS-7002 – Training/Internship Placement Plan. Visitors must be enrolled in and pursuing studies at a foreign degree-or-certificate-granting-post-secondary academic institution outside the U.S.; or have graduated from such an institution no more than 12 months prior to their exchange visitor program. Interns cannot work in unskilled or casual labor positions, in positions that require or involve childcare, elder care, medical patient care or contact, or positions that require more than 20% clerical or office support work.

In addition to program-specific criteria, all exchange visitors must satisfy the following requirements:

ENGLISH LANGUAGE PROFICIENCY

Visitors must possess English language proficiency, and sponsors are required to use one of the following objective measurements to determine an applicant’s language proficiency:

- A recognized English language test
- Signed documentation from an academic institution or English language school
- A documented interview conducted by the sponsor either in-person or by videoconferencing, or by telephone if videoconferencing is not a viable option

This evidence must be submitted with the DS-2019 request form, as the Department of State requires that this information be made available upon their request.

INSURANCE

The Center for International Education and Global Strategy at the University at Albany requires that scholars be automatically enrolled in SUNY health insurance and emergency assistance insurance. The exchange visitor must report to the Office of International Student and Scholar Services (Science Library, G40) to arrange for insurance immediately upon arrival. The U.S. Department of State also requires your dependents to have health insurance. You are required to purchase SUNY Health insurance for your spouse and children.

Two-year Home-Country Residency Requirement [212(e)]

Exchange visitors whose programs are financed in whole or in part, directly or indirectly by either their government or by the U.S. Government; or who are acquiring a skill that is in short supply in their home country (as listed on the U.S. Department of State's Exchange Visitor Skills List) will be subject to a two-year home-country residency requirement upon completion of the program.
