## **Position Announcement— Emergency Medicine Instructional Team**

### **Overview**

Recent events have brought increased attention to the critical role of emergency medicine in homeland security. EMS providers are increasingly operating alongside law enforcement to save lives in warm zones during active shooter / active violence incidents. The lifesaving techniques emphasized in Tactical Emergency Casualty Care have become a national standard. Command and decision-making, mass casualty management, and hospital coordination are consistent themes in major incident after-action reports. For almost a decade, the National Center for Security & Preparedness has been a leader in providing skill- and scenario-based training to support this evolution.

### **Minimum Requirements- Instructor**

- At least five (5) years of experience in emergency medicine
  - Certified EMT Basic, Advanced EMT (Intermediate, Critical Care, or Paramedic), R.N., N.P., P.A., D.O., M.D., or equivalent (candidates with former certifications may be considered)
- At least two (2) years of experience as an instructor

### **Minimum Requirements- Subject Matter Expert**

- At least ten (10) years of experience in emergency medicine
  - Certified EMT Basic, Advanced EMT (Intermediate, Critical Care, or Paramedic), R.N., N.P., P.A., D.O., M.D., or equivalent (candidates with former certifications may be considered)
- At least five (5) years of experience as an instructor, preferably at a regional (including major cities), statewide, federal, or national level
- Experience developing training courses and/or curriculum
  - Fluency in applying the ADDIE/PADDIE model and Bloom’s Taxonomy to adult learning is preferred.

### **Additional Minimum Requirements**

- Ability to communicate high-level concepts to an experienced audience
- Continuous study of and contributions to the subject matter
- Ability to adapt training approach and content based on the audience
- Ability to travel extensively (travel expenses will be covered or reimbursed)
- In consideration of the extensive work the NCSP conducts with the NYS Division of Homeland Security and Emergency Services (DHSES), the applicant must be able to satisfactorily complete the NYS DHSES’s background screening and credentialing process prior to employment. This includes a criminal background check.
