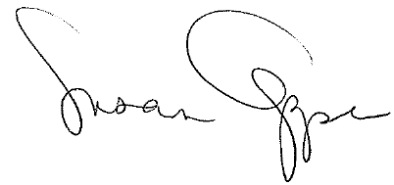

When students and I work on a topic where they take the lead on, they are first authors. In these cases, the published work might be topically related to but are not the doctoral student's candidacy paper(s) nor included in their dissertation, for which I expect the student to be the sole author.
