# **Books In Progress:**

A book entitled *Political Equality: Movement and Counter-Movement*. This book is intended as an answer to the recent spate of works claiming that (liberal) democracy is at an end or is under a threat that might lead to its demise. This strand of political thought holds liberal democracy as a constant against which a variety of new threats ranging from populism to income inequality, to the breakdown of norms of political restraint are compared. Against this claim, I argue that what these commentators view as a radical new phase is in fact one moment in the cyclical struggle between the minimalist competitive model at the political-sociological core of liberal democracy whose logic is most clearly articulated in Schumpeter's concept of competitive democracy as oligopolistic completion among parties and professional politicians, and the recurrent demand of citizens for a robust form of political equality. The argument that follows rests on what I call the Polanyi Analogy. The claim is this. Just as Karl Polanyi in *The Great* 

Transformation argued that there is a constant struggle between the attempts of democracy to subdue and re-embed the self-regulating market under the collective demands of society and the attempts of the proponents of the self-regulating market to liberate it from political control and seek to untangle it from the institutions and norms of society, there is a *prior* struggle within liberal democracy whose political sociology is rooted in the minimalist model as initially laid out by Joseph Schumpeter. This struggle is between the proponents of political equality with respect to popular sovereignty seeking to subdue the competitive model in favor of the collective demands of the citizens and the proponents of the minimalist democratic seeking to displace all political equality to voting in competitive elections with the effect of liberating the parties and political elites to pursue political cartel arrangements using the resources of the state. Rather than seeking a harmonious relation between political equality and the minimalist model of democracy as is typical of much analytic political theory, the book seeks to trace the various permutations of this recurrent conflict across a number of areas in which political equality and liberal democracy are at odds--social citizenship, finance, deliberative democracy, transnational citizenship, immigration, social protest movements, and populism. The assumption guiding each discussion is that every attempt to find a harmonious reconciliation between political equality and the liberal state simply generates new versions of the conflict—sometimes, to use Polanyi's language, representing a forward thrust for political equality, other times representing a countermovement in favor of the minimalist model of democracy.

This article discusses three different ways political theorists have understood the relation of political ideas to fields of political conflict. The article claims that attempts to test political categories and principles by the stress put on them by "real" politics can be analytically understood as following under three approaches: political reality based on existential claims about politics, political reality based on static sociological tendencies, and political reality based on a reflexive understanding of the relation of political ideas to their political sociological context. The latter means that what counts as political reality for a political theory is itself contested against other claims about political reality those concepts of political reality effect the actual field of political conflict itself.
