#### **TEACHING**

- I. Courses offered
  - 1. AENG 710: Textual Studies I (Literary & Critical Theory) (Graduate)

    This course offers a survey of the critical, theoretical, and rhetorical perspectives that are used in the study of literature and culture. It includes a representative historical overview of critical methodologies that emerged in the last century and that continue to shape current modes of critical discourse and interpretation. Theoretical schools covered include Russian Formalism, Structuralism and Poststructuralism, Marxist, Psychoanalytic, and Reader-response theories.
  - 2. AENG 516: Workshop in Fiction: Trends in Contemporary Writing (Graduate) From Romanticism and Realism to Modernism and Postmodernism, the seminar discusses specific techniques and writing strategies intrinsic to each of these literary movements. Students are expected to use texts from these periods as models or branching points for their own creative imaginings and offer and receive peer feedback in intense group sessions. Authors on the course include Lucia Berlin, Roberto Bolaño, Anton Chekhov, Lydia Davis, James Joyce, and Heinrich von Kleist.
  - 3. AENG 402Z: Advanced Writing Workshop: The Short Story (Undergraduate)
    This advanced writing workshop focuses on the 'short story,' among the oldest literary forms known to us and one that is particularly well suited to our current time-starved, chaotic age. Authors on the course include Mikhail Bulgakov, Ernest Hemingway, Franz Kafka, Ursula Le Guin, Haruki Murakami, and Virginia Woolf.
  - 4. AENG 560: Hybridity & Liminality in Modern Literature (Graduate)

    The seminar explored hybridity in literature in general, and fiction in particular, performing both stylistic and scholarly analyses on hybrid works by using successful examples of this form from a variety of periods and places: from writers including Hugo von Hofmannsthal and Javier Marías to Chris Kraus and Anne Carson, encompassing in the process movements such as Modernism, Postmodernism, and Postcolonialism.
  - 5. AENG 581: Studies in a Literary Period: Nature and Landscape Writing (Graduate)
    The seminar explored and studied the complex relationship—at once philosophical, religious, phenomenological, economic and historical—of humans to the natural world. Authors/Texts: R.W. Emerson, Nature; David Hinton, Hunger Mountain; J.A. Baker, The Peregrine; Nan Shepherd, The Living Mountain; Peter Matthiessen, The Snow Leopard; Rebecca Solnit, A Field Guide to Getting Lost; and John Williams, Butcher's Crossing.
  - 6. AENG 402Z: Advanced Writing Workshop: The Art of the Novella (Undergraduate)
    From the historical and artistic conditions prevailing at the time of its origin to the complex realities of the modern publishing marketplace, an understanding of this at once "intense" and "expansive" form—the aesthetic and critical contexts of its making and reception—offers important lessons for practicing writers. Authors/Texts: Leo Tolstoy, *The Death of Ivan Ilyich*; Herman Melville, *Bartleby*; Eileen Chang, *Lust*, *Caution*; and Denis Johnson, *Train Dreams*.
  - 7. AENG 302W: Creative Writing (Undergraduate)

The course discussed creative and critical contexts involved in the study and writing of fiction—and prose more generally—by way of classic and modern works, and theoretical studies and evaluations. Students were expected to use these texts as models or branching points for their own creative imaginings and develop their writing skills through multiple tasks and assignments. Authors/Texts: R.M. Rilke, *Letters to a Young Poet*; T.S. Eliot, *The Sacred Wood*; Anton Chekhov, *Selected Stories*; Italo Calvino, *Six Memos for the Next Millennium*; Toni Morrison, *The Bluest Eye*; Franz Kafka, *Two Parables*; and Viktor Shklovsky, *Theory of Prose*.

- 8. AENG 305V: Studies in Writing about Texts: Autofiction (Undergraduate)
  The course investigated the use and development of autobiographical material and sources in fiction, a method commonly referred to in literary discourse and criticism as *autofiction*. It attempted to question, uncover, and analyze the changing notions of 'self', 'identity', 'text', and 'authorship', which at all times are subject to the unseen laws of history. Authors/Texts: J.M. Coetzee, Youth; Sergei Dovlatov, Pushkin

- 9. TENG 270: Living Literature: Challenges in the Twenty-First Century (HONORS COLLEGE) Literature in all times and places is at once a historical and contemporary phenomenon. For literary and cultural traditions exist in a kind of continuum where the influence of the past is forever at work, modelling and shaping our response to current concerns and experiences. With the new technological global order of the twenty-first century, there is now more than ever before in history a greater intermingling of voices and styles from disparate regions of the world as well as the availability of near infinite number of old works that are being digitized and brought back into circulation at an unprecedented rate, creating thereby new configurations and challenges for the study and interpretation of literary texts, and revolutionizing the way we read, assimilate, and transmit knowledge. Authors included Anne Carson, JM Coetzee, Elena Ferrante, Franco Moretti, and Rebecca Solnit.
- 10. AENG 222: World Literature (Undergraduate)

The course traced the evolving contours of the notion of 'World Literature' through the Romantic, Industrial, Marxist, Modernist, and post-war eras; the historical, economic, and cultural conditions that first gave rise to the idea, and the models and theories (both economic and cultural), styles and works this idea in turn spawned. Authors/Texts: Heinrich von Kleist, *Michael Kohlhaas*; Gérard De Nerval, *Sylvie*; Mikhail Lermontov, A Hero of Our Time; Yasunari Kawabata, Thousand Cranes; J.L. Borges, Fictions; and Clarice Lispector, Hour of the Star.
