### **RESEARCH INTERESTS**

My research agenda concentrates on understanding the messages sent and received that impact our behavior. I examine issues within the context of the environment, organizational communication, small group communication, leadership, scientific communication, political communication, and the intersection of law, media, policy, and communication. I am examining the perceptions of what makes a leader and what makes a leader effective in both political and management settings. In addition, I am involved in a line of research on the impact of technology on the organization as well as on anticipatory socialization, which centers on what information people learn about work and the workplace. I have been involved in socialization studies of high school and at-risk students, and I have looked at the messages received and the source of these messages. Future projects will examine organizational leadership and how both a political entity and an individual can be a leader for a change in public policy. I also hope to examine vocational anticipatory socialization using a non-U.S. sample for purposes of comparison and explanations of differences in the workplace.
