Note: "Demand reduction" refers to programs and research related to drug abuse treatment, education, rehabilitation, and prevention that are designed to reduce the demand for drugs. "Supply reduction" refers to a wide scope of law enforcement-related activities designed to reduce the supply of drugs in the United States and abroad.

Each year when the President develops the National Drug Control Strategy, changes may be made to existing programs and new programs often are added. Some data have been revised by the Source and therefore will differ from previous editions of SOURCEBOOK.

<sup>a</sup>The data presented represent the following types of budget authority: 1996-1999, "actual"; 2000-2010, "final" budget authority enacted in the prior year; 2011, current year "enacted"; and 2012, "requested" for the budget year under formulation. Percents may not add to 100 because of rounding.

<sup>b</sup>Based on a directive from Congress, stating that "the Federal drug control budget should represent the full range of Federal spending, including costs associated with the consequences of drug use," the Office of National Drug Control Policy (ONDCP) restructured the national drug control budget. A review of Federal programs resulted in identifying additional departments/agencies/programs that utilized Federal resources to "reduce drug use and its consequences." ONDCP revised the drug control budget figures to include the additional departments, etc. beginning with FY 2004. Therefore, data for 2004 and beyond are not comparable to data for years prior to 2004 (*FY 2012 Budget Summary*, p. 5).
