Where possible, the data presented are actual salaries. In jurisdictions where some judges receive supplements, the salary figures are the most representative available: the base salary, the midpoint of a range between the lowest and highest supplemented salaries, or the median. National averages for the highest courts and general trial courts are based on figures for the 50 States and the District of Columbia. For intermediate appellate courts, the average is based on the 39 States that have such courts.
