Note: On Mar. 1, 2003, the Immigration and Naturalization Service transitioned to the U.S. Department of Homeland Security and two bureaus were formed to handle enforcement activities: U.S. Customs and Border Protection and U.S. Immigration and Customs Enforcement. These data reflect the administrative reason, which is the legal basis for formal removal (including deportation and exclusion) of persons identified as aliens. Some aliens who are criminals may be removed for a reason (charge) other than those listed above. Removal categories have been revised by the Source pursuant to a revision in the law effective Apr. 1, 1997. Some data have been revised by the Source and may differ from previous editions of SOURCEBOOK.

^aIncludes those aliens charged with "entering without inspection" prior to the Apr. 1, 1997 revision in the law.
