Note: Thirty-seven States and the Federal Government had death penalty statutes in effect during 2008. New Mexico enacted legislation repealing the death penalty, effective July 1, 2009, therefore in 2009 thirty-six States and the Federal Government had death penalty statutes in effect. The U.S. military also has a death penalty provision, but the Bureau of Justice Statistics does not collect data for persons under military death sentence. The following jurisdictions with death penalty statutes reported no Hispanics or females under sentence of death on Dec. 31, 2008 or 2009: Arkansas, Colorado, Kansas, Maryland, Missouri, Montana, New Hampshire, New York, South Dakota, Washington, and Wyoming. Some data for yearend 2008 have been revised by the Source and will differ from previous editions of SOURCEBOOK.
